This video is deeply troubling. Council agreed that this was a nuisance (one week from today), and apparently no directive was passed on to the police. If there was one passed on, please send me a copy for our files. This truck is also violating the 2016 Staff memo which states that trucks will be cited for blocking the sidewalk. The Staff memo aligns with our Ordinances. Much like Mr. Thompson receiving a notice for his shrubbery being 8" over the sidewalk, a citation must be delivered for blocking the sidewalk with a noisy truck, as this truck has fit in the loading area in the past. They could also find a different truck to fit the bay within the enclosure, to minimize some of the noise. In addition to the statements of Council that this should be enforced, I would like a copy of the Notice of Violation that is sent to the property owner for this violation. If I do not get responses to either of these, I will assume that you are willingly not adhering to the application of our Ordinances on the Greenlife side of the street. To which, we will maintain this as part of the record. If you have been directed to look past these violations, please include the directive so we may maintain the same as a reflection of information beyond what is said in the public record in hearing.
