- Cars displaying the permitted parking hang tag will **not** be issued a citation even if the hang tag is out of date.
- All trucks parked on Maxwell Street either waiting for a loading dock to open up or is in the act of loading and unloading will be issued a citation.
- **All vehicles including trucks that are in violation Section 19-137 which prohibits parking at several places including, but not limited to, within intersections, in front of private driveways, near a fire hydrant, and pedestrian crosswalks will be issued a citation.**
- **Trucks that are in the active process of loading and/or unloading at either of the two loading areas will be issued a citation if they are blocking the sidewalk without allowing a minimum clearance of 4 feet for the pedestrian access route as mandated in the Accessibility Guidelines for Pedestrian Facilities in the Public ROW (July 26, 2011).**
- This employee will only be able to issue parking-related citations.
- The activity log work sheets will be submitted to the Transportation Department on a weekly basis and the data will then be entered electronically.
