In Sarasota we have erected signs in certain lots indicating that Back-in Parking is Prohibited for the very reason that it is hard to monitor legal registrations unless vehicles park head-in. This is only done in larger lots/garages that would otherwise take a significant amount of time to walk behind backed in vehicles and verify the plates. It has been a subject of hefty local debate and disdain by most.

I would advocate that in the state of Florida that, and other states where this is a concern, parking and policing industries create political influence to modify existing state laws, and thereby require license plates in both front and rear of the vehicle.

We implemented LPR in August and we dealt with this issue by adding a new parking regulation that simply states all vehicles must park with a license plate visible from the drive lane. If a vehicle has two plates then they can back in if they choose otherwise they need to pull head in.
