Subject: Request for Special Prosecution assistance

Dear Leslie,

Since December of last year three out of five of our most experienced ADAs with murder trial experience have left the Office (another mid-level ADA just left last month). We still have the experience and the capacity to handle a number of homicides but we are significantly stretched at this time and request assistance.

After consultation with my staff, the 40th Prosecutorial District DA asks pursuant to NCGS 114-11.6 that NC AG Special Prosecutions consider acceptance of the homicides below. Assistance in these cases would be of significant value to local prosecutors because: 1) Logan and Nesanet have legal process out of County/State; or 2) the homicides involve multiple defendants; and 3) all defendants are now in BCDF custody.

I'll include pending Buncombe charges as shown in ACIS below the defendant's name, date of offense for the homicide, and a URL citing to publicly released facts (again, we're asking that you take the murders and charges related to the murder not necessarily all pending charges for each defendant but we can certainly discuss further as needed):

1 – Alfred Logan: offense date 11/17/2021

Mr. Logan is charged capitally in Alabama. In addition after being charged in Buncombe, Logan was sent to safe-keeping in Central Prison and charged with murder in Wake County (22CRS002512).
